NOTE: Based upon the total number of applications scored and ranked, and the total funds available, the Department established the following point score cut-off of 116 for geographic areas of North, South, and Rural. Tiebreaker maximums are as follows: for Rural projects, a maximum tiebreaker score of .410638; for projects located in the North, a maximum tiebreaker score of .29180; and for projects located in the South, a maximum tiebreaker score of .291379. Senior set-aside point score cut-off of 116, with maximum tiebreaker of .486364; and for Supplemental non-tax credit project point score cut-off of 112, with maximum tiebreaker of .391837, would be necessary for an application to fall within the competitive point score range.
