For all income categories, the income limits for households larger than eight persons are determined as follows: For each person in excess of eight, add eight percent of the four-person "50%" limit to the "50%" limit for eight persons and round the answer to the nearest \$50. For example, the nine-person "50%" limit for Yuba County equals \$41,260 ($\$29,450 \times 0.08 = \$2,356$, added to $\$38,900 = \$41,256$, rounded to $\$41,260$).
